

## **Election Schedule, 2010**

### ***Election of Council Members for the term 2011 & 2012 :***

- (i) Issuance of Circular inviting Nominations :  
**June 7, 2010 (Monday)**
- (ii) Last date of Receiving Nomination :  
**July 7, 2010 (Wednesday)**
- (iii) Consent/Withdrawal of Nomination :  
*Latest by* **August 2, 2010 (Monday)**
- (iv) After scrutiny of the nomination papers to the satisfaction of the President, the Ballot Papers duly signed by him will be issued to all Members, Under Certificate of Posting :  
*Latest by* **August 20, 2010 (Friday)**
- (v) The Ballot Papers to be returned to reach the President :  
*Latest by* **September 20, 2010 (Monday) by 5.00 p.m.**
- (vi) A panel of Scrutinizers consisting of the President or his Nominee and two other members nominated by the President from amongst the members of the Society, who are not themselves candidates for election, will open the ballot papers, prepare a tabulated statement and sign it in the presence of the President or his Nominee.  
  
The President may Co-opt Members to assist the panel of scrutinizers for Counting Votes. Candidate's Nominee may be present as observer during the counting of ballots.  
  
At least two scrutinizers, one of whom must be the President or the Vice President will have to be present to check and count the Ballot Papers.  
  
**Counting on September 21, 2010 (Tuesday)**
- (vii) The Election Results of the newly elected members of the Council will be communicated to the candidates :  
*Latest by* **September 27, 2010 (Monday)**

### ***Election of Office Bearers for the term 2011 & 2012 :***

- (viii) Issuance of Circular Inviting Nominations for election of Office Bearers :  
*Latest by* **October 4, 2010 (Monday)**
- (ix) Last date of Receiving Nomination :  
**November 8, 2010 (Monday)**
- (x) Consent/Withdrawal of Nomination :  
*Latest by* **November 15, 2010 (Monday)**
- (xi) After scrutiny of the nomination papers to the satisfaction of the President, the Ballot Papers duly signed by him will be issued :  
*Latest by* **December 1, 2010 (Wednesday)**
- (xii) The Ballot Papers are to be returned to the President at the stipulated date :  
*Latest by* **January 3, 2011 (Monday)**
- (xiii) The Ballot Papers will be scrutinized by a panel of scrutinizers appointed by the President and in presence of the President or his Nominee.  
  
The Contestants or their Nominees, however, will be allowed to be present as observers.
